The sealed quotation containing schedule of items (Annexure-I) and terms & conditions etc. duly filled & signed on each page by the bidder shall be submitted to the "The Director, Directorate of Lighthouses & Lightships, Deep Bhavan, Gandhi Nagar, Kadavanthra P.O, Kochi-682020 on or before 19.11.2025 up to 17:00 Hrs.

SCOPE OF THE WORK FOR HIRING OF BOAT SERVICES FROM AGATTI ISLAND TO SUHELIPAR / CHERIYAKARA, VALIYAKKARA ISLANDS (TO AND FRO)

- i. Boat having the length of 50' and above including dingy for trip from Agatti Island to Suhelipar / Cheriyaakara, Valiyakkara Islands (to and fro)".
- ii. One Trip means Starting from **Agatti - Suhelipar -Valiyakkara -Agatti** including One Night Stay at Suhelipar / Cheriyaakara, Valiyakkara Islands. In case of additional night halt at Suhelipar / Cheriyaakara, Valiyakkara islands charges for the same may be claimed as quoted by the bidder per night.
- iii. Provision for Food Rations/Fresh Water etc. catering 03 Times a Day to be provided by the Contractor for 04 to 09 Officials of DLL during Each Trip. Crews should have experience in visiting Suhelipar / Cheriyaakara, Valiyakkara Islands.
- iv. Charges for food per DLL official / Per day (03 Times) as quoted by the bidder shall be reimbursed.
- v. Fuel, Lubricants, Boat crew, Dingy and any other expenses necessary for the safe voyage of boats 50 feet and above, for trips from Agatti to Suhelipar / Cheriyaakara, Valiyakkara Islands and return shall be borne by Contractor.
- vi. The boat shall be equipped with the latest communication devices, such as VHF radio and GPS, as well as high-quality lifesaving appliances, including life jackets, to ensure a safe and secure voyage.
- vii. During Cruise Programme of Dept Vessels MV Sagar Deep II and MV Indira Point Embarkation and Dis Embarkation need to be done as when required in Suhelipar / Cheriyaakara, Valiyakkara Islands.
- viii. Necessary Permissions and clearances required for Sailing to Suhelipar / Cheriyaakara, Valiyakkara Islands need to be taken by the contractor and no additional payments shall be made.

ANNEXURE-II

TERMS & CONDITIONS

- 1) The sealed quotation superscribed with Name of work: **"Hiring of boat of length of 50' and above (including dingy) for trip from Agatti - Suhelipar -Valiyakkara -Agatti"** shall be submitted on or before 19.11.2025 up to 17:00 hrs through Indian post/ courier or by hand to the Station In-charge, Agatti Lighthouse. The quotations shall be addressed to "Director, Directorate of Lighthouses and Lightships, Cochin. The offer submitted in enclosed schedule received on or before due date and time shall only be considered.
- 2) The address given in the bid shall be deemed to be contractors address and any correspondence sent on that address shall be considered to have been delivered to the bidder. No claim shall be entertained for the reason of forfeiture of the sum deposited in case the correspondence is received back undelivered.
- 3) The scheduled day for opening the sealed bids, if declared to be holiday due to any reason, the same shall be opened on next immediate working day at 16:00 hrs.
- 4) One trip shall be defined as the journey from **"Agatti - Suhelipar -Valiyakkara-Agatti"**.
- 5) The bidder should quote the rate inclusive of all charges, such as fuel, boat crew, dingy and any other expenses necessary for the safe voyage of boats 50 feet and above, for trips from Agatti to Suhelipar/Valiyakara Islands and return.
- 6) The contractors shall quote the amount, both in words and in figures. If there is any difference between the amount given in figures and that of words, the rate quoted in words alone shall be considered and accepted on record.
- 7) No price escalation will be entertained under any circumstances.
- 8) The rates shall be quoted in the enclosed schedule marked as **"Annexure-I"**. Rates quoted in any other form/ format shall not be accepted.
- 9) The contractor shall satisfy himself regarding the nature of work to be done, its scope etc., the conditions of contract, specification, schedule etc. before offering their rates.
- 10) The boat shall be equipped with the latest communication devices, such as VHF radio and GPS, as well as high-quality life saving appliances, including life jackets, to ensure a safe and secure voyage.
- 11) The boat shall remain at Suhelipar/Valiyakara Islands until the work at the lighthouse(s) is completed."
- 12) Sailing will be from Agatti to Suhelipar/Valiyakara Islands and back to Agatti for the officials of the Directorate of Lighthouses and Lightships and equipment's as per the order from Director of lighthouses & Lightships, Cochin.
- 13) Minimum 4 nos. crew on board during trip
- 14) Embarkation and Disembarkation from the department ship at Suhelipar / Cheriyakara, Valiyakkara as and when required during the trip
- 15) The journey must be executed in such a way to ensure that sufficient time (minimum two days) is available for the staff for maintenance activities at Cheriyakara /Suhelipar Valiyakkara
- 16) Provision for essential food items shall be carried on boat.
- 17) A dinghy boat shall invariably accompany with the main boat during the trip to islands.
- 18) The contract shall be initially for 1 year which will be further extended for another period of 02 years on yearly basis with the same terms and conditions on satisfactory performance of previous year.

- 19) In the event of failure of boat during voyage, alternate boat of the same specification shall be arranged and no extra charge shall be payable for the same. No additional charges other than the amount quoted will be paid under any circumstances.
- 20) The successful bidder shall be decided based on lowest amount quoted by the bidder.
- 21) The lowest bid, once accepted, is not transferable to anyone. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases, the person appearing on behalf of the company shall have to produce the authorization letter in a proper format issued from a competent authority of the company. Any request to change the name of the bidder in the bid after submission of the bid shall not be entertained.
- 22) The successful bidder shall observe and perform all the guidelines, rules, regulations and orders issued by Central/ State Government or any Local Authority.
- 23) If the successful bidder refuses to undertake the work after being declared L1, they will be blacklisted and debarred from participating in government projects for the next three years.
- 24) The contractor should follow all the instructions issued by the Director, Directorate of Lighthouses and Lightships, Cochin, or his representative.
- 25) The contractors should follow all the instructions & guidelines related to safety & operation, issued by Lakshadweep Administration (Dept. Of Ports).
- 26) The contract shall be governed by the law of the India. Lawsuits and other proceedings arising out of or in connection with the contract works shall be instituted in Courts of law at Ernakulam/Cochin only.
- 27) The interested bidders may contact the Navigational Assistant Grade-I, Agathi Lighthouse, Agatti for any query/ clarification regarding scope of work from 23.10.2024 to 02.11.2024 between 10:00 Hrs. to 16:00 Hrs on all working days with prior intimation.
- 28) The bidder shall submit the copy of valid PAN Card, GST registration and bank account details for payment. The PAN Card shall be linked mandatorily with the AADHAR.
- 29) TDS IT of 1% shall be deducted of total Invoice value If the PAN is registered as Individual or proprietorship and TDS of 2 % shall be deducted of total Invoice value If the PAN registered as a Firm/Company.
- 30) TDS IT of 20 % shall be deducted of total Invoice value If PAN is not linked with AADHAR.
- 31) The tenderers should have valid registration and certificate for the operation of the Boats.
- 32) Specifications of the Boats, scope and nature of work and other requirements are given in
- 33) **"Annexure-I"** and the quotation is to be submitted in the format given in **"Annexure-I"** (Technical Bid).
- 34) The rates quoted shall be per boat per day basis and shall be quoted both in figures and in words. The rates quoted should be all-inclusive, including Fuel, Oil and Lubes. No mobilization and demobilization charges will be paid separately.
- 35) The Director, if deemed fit, may empanel more than one service provider, as per the L 1 Tender rates.
- 36) Taxes/ Levies/ Duties, if any, to be paid extra should be clearly indicated. Charges not included in the tender shall not be paid.
- 37) The successful bidder will have to deposit an unconditional Performance Bank Guarantee of Rs.10,000/- (Rupees Ten Thousand only) within 10 days of receipt of award of contract. valid till the contract period + 60 days
- 38) Performance Bank Guarantee to be drawn in the form of DD / FDR from any Nationalised / RBI approved Bank in favour of "The Director, Directorate of Lighthouses & Lightships, Deep Bhavan, Cochin", payable at Ernakulam

- 39) The Boats/ Boats will be inspected, if felt necessary, to assess the suitability and its sea worthiness.
- 40) The tenders are liable to be summarily rejected, if any of our terms and conditions is not satisfactorily complied with.
- 41) The contractor may present his bills for payment in triplicate duly pre-receipted on completion of the work through the Station in-charge
- 42) The tenderers should furnish along with the tender the layout plan and specification of the Boats along with copies of all the relevant certificates for survey/ classification/ society, etc.
- 43) The tenderers should furnish specifications of all navigational and safety equipment including fire extinguishers installed on board the Boat.
- 44) The working schedule shall depend upon the local conditions and nature of work. The contractor therefore should be ready to make the Boat with crew available as per the schedule of work which shall be communicated well in advance.
- 45) The crew members are expected to provide all necessary help and assistance as required for operations.
- 46) If the contractor refuses to execute the work after issuance of the work order, or fails to complete the assigned work, the Director, DLL Cochin, reserves the right to blacklist the contractor for a period of three (3) years.
- 47) Lawsuits and other proceedings arising out of or in connection with the contract shall be instituted in Courts of law at Ernakulam/ Cochin only.
- 48) The Director, Directorate of Lighthouses & Lightships, Cochin reserve the right to reject any or all the bids without assigning any reasons. The Director, Directorate of Lighthouses & Lightships, Cochin also reserves the right to withdraw the quotations invited for "Hiring for boat of length of 50' and above (including dingy) for trip **Agatti - Suhelipar - Valiyakkara- Agatti**". The decision of the Director, Directorate of Lighthouses & Lightships, Cochin shall be final in this regard during the process of this auction at any stage.
