1.0 Eligibility Criteria

1.1 Experience in similar works

It is an essential requirement that the firm must have relevant experience in similar works and has taken up, executed and satisfactorily completed at least one similar work amounting to not less than Rs.73,760/- or two similar works each amounting to not less than 46,100/- or three similar works each amounting to not less than Rs.36,880/-during last seven years ending 31March 2025.

Similar work means "Supply of Office Furniture items "in Central Govt./State Govt./Public listed/ PSUs/ Reputed Firms

1.2 The firm shall have GST registration certificate, PAN Details

1.3 Bidder has to submit a non blacklisted affidavit on their firm's letter head for last 03 years".

1.4 The firm must have valid registration and office address in Tamilnadu / Puducherry. Address proof Shall include MSME certificate,Business registration certificate in Tamilnadu/Puducherry.

1.5 Bidder has to submit detailed technical specifications of the items as per Annexure 'A'.

1.6 Bidder has to submit the Proof for the similar work experiences like completion certificates from clients not below the rank of Manager/Assistant Executive Engineer/Administrative officer or equivalent designations with relevant purchase order /GeM CRAC with relevant GeM Contract.

***It shall be mandatory to meet all the above essential criteria and firms should submit copies of all certificate/documentary evidence of the same along with the bid . Firm whose bid does not meet above criteria will be disqualified.**

2.0 General

- DLL shall mean the Director of Lighthouses & Lightships, Chennai having its office at Deep Bhavan, 5/20, Jaffer Syrang Street, Chennai – 600001, Tamilnadu and shall include his legal representatives and successors and permitted assigns.
- The L1 Bidder has to submit Performance guarantee in the form of PBG/FDR shall be in the name of the Director, Directorate of Lighthouses and Lightships,Chennai from the commercial banks,which will be equivalent to 5% of the contract value and shall remain valid for 60 days beyond the warranty period & all contractual obligations from the date of completion of the work.The Performance Guarantee shall be released only after completion of 1 year of warranty period.
- Accepting authority shall be DLL or his authorized representative.
- The supply of items shall be completed within 15 days to the entire satisfaction of the Director or his authorized representative from the date of supply order issued.
- The Items be supplied shall confirm the quality standards whichever applicable.
- The DLL Chennai reserves the right to reject the work contract at any time without assigning any reasons thereof.
- Bidders have to furnish the detailed specifications of the items during evaluation and enquiry. Bids not confirming quality standard of items will be rejected..

- Bidders who quotes with low quality standard will be rejected.
- The Bidder shall study thoroughly the “schedule of work in Annexure A & terms and conditions in Annexure B” before quoting their rates.
- The lowest quoted bidder shall have no right to claim the award of work,for which The Director,Direcorate of Lighthouses and Lightships,chennai’s decision is final.
- Items shall meet requisite standards.Item prepared shall be inspected at different stages by a representative of DLL Chennai before supply. Items shall be supplied only on satisfactory inspection of furniture for quality, aesthetics,Specification of wood material.The successful bidder shall intimate the readiness of raw material for inspection(Before polishing/warnishing) and later to check the built quantity and aesthetics.

- **Work Completion Acceptance:**Furniture items with reputed brands and of good quality only will be accepted .Work completion will be accepted only after ascertaining the satisfactory supply of all the furniture items to the mentioned Delivery location as per the Shedule of work Annexure-A and Terms and Conditions Annexure B.
- **Payment for Works:**Payment will be made on final account basis after successful satisfactory supply of the items to the Delivery location.No extra payment will be made other than the quoted rate.


