General Percentage Rate Tender (4) In case the lowest tendered amount (estimated cost + amount worked on the basis of percentage above/below) of two or more contractors is same, such lowest contractors will be asked to submit sealed revised offer in the form of letter mentioning percentage above/ below on estimated cost of tender as the case may be, but the revised percentage quoted above/below on tendered cost should not be higher than the percentage quoted at the time of submission of tender.	Section IV, General Conditions of Contract 1. General Percentage Rate Tender (4) In the event that two or more bidders quote identical rates/percentages and become L1, such L1 bidders shall be requested to resubmit their Financial Bids (BoQ) through the CPPP portal with revised rates. The bidder quoting the lowest rate in the resubmitted Financial Bid (BoQ) shall be declared as the successful bidder, and the work order shall be issued accordingly based on the revised BoQ. The revised percentage quoted above/below on tendered cost should not be higher than the percentage quoted at the time of submission of tender.
