**Report of the Committee for appointment on the compassionate Ground
in Directorate General of Lighthouses and Lightships, Noida.**

The Committee was constituted vide Headquarters office, Noida, letter No. A-52/1/2020-Admin I dated 04-09-2025 for appointment on compassionate grounds (Annexure- I).

2. The Committee decided to adopt the assessment parameters prescribed by Directorate General of Training, Ministry of Skill Development and Entrepreneurship vide O.M. No. DGT-A-12012/2/2022-Estt-II dated 16.02.2023, for evaluating applications received under the Compassionate Appointment Scheme.

3. Accordingly, the Competent Authority issued Office Letter No. A-52/1/2020-Admn.I dated 13th March, 2026 to all 30 applicants, through the respective Directorates, requesting submission of the revised proforma along with all relevant supporting documents and authentic proofs by 30.03.2026 for assessment of their eligibility.

4. The Committee examined the applications and supporting documents received through the concerned Directorates. The evaluation was carried out with due diligence based on the information furnished by the applicants, duly verified and vetted by the respective Directorates, and in accordance with the provisions and conditions prescribed in the revised proforma. While assessing the cases, the Committee also adhered to the guidelines contained in DoP&T O.M. No. 14014/1/2022-Estt. (D) dated 02.08.2022.

5. The Committee observed that revised applications, submitted in the prescribed proforma circulated to the candidates through the respective Directorates, were received from 27 out of the 30 candidates. All 27 applications were duly verified by the concerned Directorates. Accordingly, the Committee evaluated these 27 revised applications. Of these, the following two applications have been rejected:

- ii. ii) Shri Dev S/o Late Mrs. Santosh was rejected as the applicant does not possess the requisite minimum qualification (X class pass).

5. The committee concluded and finalized its report on 06.08.2026. The Evaluation Sheet is attached as Annexure- II and list of applicants, along with their numerical gradings is attached as Annexure- III.

Based on the availability of post and essential qualification for the available post, the Competent Authority may appoint applicant/s on compassionate Grounds.

While applying 100 points scale parameters including points, if situation arises that some candidates secure equal marks in merit, in such cases the tie breaking factor can be per dependent available income i.e. total of first three financial parameters prescribed in Report (Pension-unannualized, total terminal benefits and annual income of earning members) divided by total number of dependents. The lesser the per dependent available income, the higher the rank amongst the applicants whose scores had a tie.
